Soeparno, the meeting resulted in six conclusions.

Pertama, Komisi VII mengapresiasi Dirut PHE atas kinerja PT PHE tahun 2023, antara lain berkontribusi sebesar 68% dari produksi minyak, dan 33% produksi gas nasional, menemukan potensi migas yang besar (big fish), mengakuisisi Partisipatif Interest Blok Masela serta mengimplementasikan Enhanched Oil Recovery (EOR) dan Carbon Capture Utilization and Storage (CCUS).

As a start, Commission VII expressed its appreciation for the performance of the President Commissioner of PT PHE in 2023 by contributing 68% to national oil production and 33% to national gas production, scoring 'big fish' oil and gas discovery, acquiring participating interest in the Masela Block, and implementing Enhanced Oil Recovery (EOR) and Carbon Capture Utilization and Storage (CCUS).

"Komisi VII DPR RI mendesak PHE untuk bekerja maksimal meningkatkan lifting migas dalam rangka mendukung target produksi minyak bumi nasional sebesar 1 juta barel per hari (BPOD) dan 12 miliar standar kubik per hari (BSCFD) pada tahun 2030," ujar Eddy membacakan poin kesimpulan kedua, yang disepakati oleh seluruh peserta rapat yang hadir di Gedung Nusantara I, Senayan, Jakarta, Rabu (27/3/2024).

"Commission VII urges PT PHE to maximize oil and gas production to support the national oil production target of 1 million barrels per day (BPOD) and 12 billion standard cubic feet per day (BSCFD) in 2030," said eddy while reading the second point of conclusions, which was agreed upon by all participants at the meeting held at the Nusantara I Building, Senayan, Jakarta, Wednesday (27/3/2024).

Komisi VII DPR RI mendorong PT Pertamina hulu energi untuk meningkatkan komunikasi dengan komisi VII DPR RI, yang dapat membantu menyelesaikan permasalahan yang dihadapi oleh PT PHE dalam mencapai target lifting Migas. Diantaranya melakukan percepatan persetujuan perizinan lingkungan dan kemudahan pembebasan lahan dalam rangka meningkatkan lifting Migas.

Additionally, Commission VII urges PT PHE to improve communication with Commission VII to help the company overcome challenges in achieving oil and gas production targets. This includes accelerating environmental permit approval and land clearance process to increase oil and gas production.

Selain itu, Komisi VII DPR RI juga mendesak PHE untuk mendukung bahwa proyek abadi Masela, agar dapat mulai berproduksi sesuai target pada tahun 2029. Dalam kesempatan itu, Komisi VII DPR RI memberi catatan khusus serta mendesak Dirut PHE agar dapat memberikan kontribusi terhadap peningkatan produksi migas nasional sejalan dengan peningkatan aset PT PHE.

Moreover, the Commission also called on PT PHE to support the Abadi Masela project, allowing it to start production according to the target in 2029. Commission VII made special remarks in this regard and requested the President Commissioner of PT PHE to contribute to the increase in national oil and gas production in line with the increase in PT PHE's assets.

"Komisi VII DPR RI meminta Dirut PT PHE dan seluruh Direktur regional PT PHE untuk menyampaikan jawaban tertulis atas semua pertanyaan anggota Komisi VII DPR RI dan disampaikan paling lambat tanggal 3 April 2024," tutup Politisi Fraksi PAN ini membacakan poin terakhir kesimpulan RDP tersebut.

"Commission VII requests the President Commissioner of PHE and all regional Directors of PT PHE to provide the responses in writing to all the questions from Commission VII members and submit them by 3 April 2024," concluded the National Mandate Party politician in closing the Hearing. (ayu/aha)



Dengan lanskap seperti itu, tak pelak Indonesia memiliki potensi kekayaan sumber daya laut yang luar biasa, khususnya di sektor perikanan. Sayangnya negara ini belum ada badan dan peraturan perundangundangan mengenai keamanan keselamatan laut yang komprehensif. Untuk itu, Wakil Ketua Panitia Khusus which 62% of its territory consists sea and waters, Indonesia has great potential for marine resources, especially in the fisheries sector. However, it is regrettable that the country lacks the comprehensive legislation and agencies dealing with marine security and safety.

Through the meeting with the Central Java Regional Police, Deputy Chair of the House Special Committee on Maritime Affairs Bill Endro Hermono wished to solicit input from various stakeholders. This is part of the Committee's endeavors to foster synergy between ministries. police, and institutions/agencies maintaining security, safety, and law enforcement at sea.

"The threats to maritime security are highly complex and diverse. It includes security, economic, environmental, and social aspects, such as piracy, illegal, unreported, and unregulated (IUU) fishing, marine pollution, terrorism in the maritime environment, natural disasters, cyber security, and regional and international conflicts," Hermono said at the Central Java Regional Police Headquarters in Semarang, Central Java Province, Tuesday (20/3/2024).

Lebih lanjut Endro mengungkapkan bahwa Indonesia terdapat masalah dimana termasuk negara tidak yang mempunyai coast guard (penjaga pantai/pesisir). "Sehingga perlu dimasukkan ke undang-undang mengenai apa dan fungsinya seperti apa," katanya.

Additionally, Hermono said it poses a risk when Indonesia does not have a coast guard. "So our legislation needs to regulate coast guard and what its functions entail," he said.
